Postal Ballot Form for Council Elections 2022

PLEASE READ THE FOLLOWING NOTES CAREFULLY:

1. The postal ballot must indicate clearly the candidate(s) for whom the member wishes to vote. [For the positions of 'Vice-President', you may vote for fewer than the maximum number indicated.]
2. Members must :
 - a) Sign the postal ballot form and provide their full name.
 - b) Place the signed postal ballot form inside a white envelope or the envelope provided by MNS.
 - c) Seal the envelope, **write their name and membership no. clearly and sign on the outside of the envelope.**
3. A Family Member is entitled to one (1) or two (2) votes, depending on the number of adults registered. The correct number of postal ballot forms are provided to each Family Member. Each voter shall complete the postal ballot form and follow the procedures as set out in item 2 above.
4. The entire postal ballot form shall be null and void under any of the following circumstances :
 - a) Where a member has voted for more than the full number of Council members to be elected;
 - b) None of the boxes in the ballot form are crossed;
 - c) The ballot form is incomplete or unsigned; or
 - d) The outside of the envelope does not have the name or signature of the member.
5. The completed and signed postal ballot form must be received by the Honorary Secretary of the Society at MNS Headquarters no later than 4.00 pm on Thursday, 22 September 2022 (two working days before the date of the AGM).
6. Ballots delivered by hand must be in the hands of the Chairman of the AGM by the time scheduled for the commencement of the meeting (no later than 10.30am on 24 September 2022) and will only be opened at the time of the meeting.
7. Postal ballots once delivered to the Honorary Secretary or the Chairman cannot be withdrawn.
8. The nominees' profiles can be viewed and downloaded from MNS website (www.mns.my). You will need to log in with a generic username and password at the "Member Login" section on the front page as follows :
